Context

Regarding the challenges associated with reaching the Millennium Development Goals in the field of water supply and sanitation, two key points have been highlighted by the international community: the need to increase financing at local level and, at the same time, the need to enhance local capacities to manage water resources. Solidarity financing mechanisms contribute, among other means, to meet both these needs. Based on sustainable ties of solidarity and offering a bond between people as well as financing, these mechanisms target funds directly to local stakeholders and at the same time promote the sharing of experiences and building of capacities.

Session Objective

The objective of this special session is to examine how the African stakeholders in decentralised financing mechanisms based on solidarity perceive these mechanisms, what their advantages are and how they feel they could be advanced and improved. The results of a survey on this topic will be presented, leading to further debate among the local authorities present in the panel and the audience.

In addition to debating issues relating to North-South financing, discussions shall also look at the feasibility of implementing mechanisms based on solidarity between the people within a country, whereby the more wealthy users show their solidarity with those less well-off.
