AREAS and Activities

Mount Lebanon:

- Water and Waste Water;
- Water Establishment and Union of Municipalities.

South:

- Water;
- Water Establishment and ACWUA.

ACTIVITIES continued

- Equipping two new drilled wells (Bhamdoun and Taaziniyeh, Aley District, Mount Lebanon);
 - No clear update;
 - Design by MOEW.

ACTIVITIES continued

- Upgrading and extending wastewater pipelines with separation of storm water (Ouzaii, Baabda District, Mount Lebanon)
 - Design completed by the Union of Municipalities;
 - Upgrading of existing line connected to the main waste water system;
 - Connecting at least 300 HH.

ACTIVITIES

- Rehabilitating two pumping stations (Ouadi Jilo nr 2 and Batoulay, Tyre District, South);
 - Rehabilitation of wells;
 - Replacement and installation of booster pumps;
 - Electrical and hydraulic rehabilitation;
 - General maintenance.

ACTIVITIES continued

- Conducting community-level outreach to promote sustainable and efficient water use (Tyre and Baada Districts);
 - Enhancing awareness to integrate the operation of Municipality in the frame of the Law 221 as well as for the community on right and duties in the water and wastewater schemes (Tyre and Baabda Districts);
 - Awareness on community level for the water conservation and protection;
 - Increase the number of subscribers (Tyre) (continuation of MIYAHCON).

ACTIVITIES continued

- Strengthening and scale up the capacities of WEs in Water Management Safety Plan and NRW reduction (ML, Tyre and Bent Jbeil Districts).
 - Baseline study for the development of Water Management and Safety plan and delivering recommendations for Beirut-Mount Lebanon Water Establishments;
 - Implementation of training for the SLWE staff on the Water Management & Safety Plan already developed in the Water service area of Bent Jbeil and Marjayoun;
 - Development of a new Water Management & Safety Plan for the Water service area of Tyre.

ACTIVITIES continued

- *Increase the capacities of authorities for the improvement of maintenance mobilization of the water services at SLWE in Bent Jbeil District;*
- Provision of equipment, tools, machineries and office assets for SLWE to facilitate operation and maintenance intervention;
- These activities are to be done by ACWUA in the frame of the PIP that was completed by the MIYAHCON.
