# News from HawkaMaa-EU Project

#### PARTNERS' ACTIVITIES IN THE LAST THREE MONTHS

The HawkaMaa-EU project, funded by the European Union, continues its activities to enhance water governance public water and wastewater services in Lebanon, benefiting all communities in need in Lebanon. Consortium comprising various organizations is actively involved, with ACTED, ACF, WW-GVC, LebRelief, and Solidarités International serving as implementing partners, supported by IMPACT, LCPS, Nahnoo, and LEWAP. During this quarter, infrastructure works completed or are nearing completion in Tleil (Akkar), Lehfed (BML) and Brak (South), adding to the infrastructure schemes that had been completed in previous periods in the Bekaa and South Beirut. The partners will dedicate the following months in monitoring service improvements and rolling-out payment and subscription campaigns, in collaboration the regional Water Establishments, and to support the sustainability of the schemes. In addition, network improvements and maintenance works have been conducted throughout the quarter in more than 20 locations across Lebanon. Consortium partners also launched works to solarize 11 pumping stations in BML, the North

and the Bekaa.

Lastly, the Consortium also partnered with Convergences to organise the first edition of the Convergences Forum in Lebanon, centering water and wastewater solutions. The Forum will be in late September, a multistakeholder event, open to all water professionals and to the public, and aims to advance discussions on SGD 6. The programmation for the Forum is being co-designed through actors consultation (Working Groups), gather non-governmental which organisations, academia, institutional and private sectors actors. LEWAP has ended their contract as part of the HawkaMaa-EU project accomplishing 9 workshops throughout the period of 2021-2024 on the activities conducted by the implementing partners in the consortium.

## **MEETING WITH LCSW**

The Lebanese Civil Society for Water (LCSW), implemented by LEWAP and LebRelief as part of the HawkaMaa-EU project is a network of Lebanese NGOs and Civil Society Organizations (CSOs) active in the water and environment sector, who are willing to increase

their knowledge and intervention capacities for water and wastewater. The LCSW meets regularly on a monthly basis to discuss updates from the sector as well as strategic topics, and receives capacity building trainings provided by the project's partners.

# JOINT WORKSHOP: UPDATED NATIONAL WATER SECTOR STRATEGY 2024-2035 + SOCIO ECONOMIC BARRIERS TO SUBSCRIPTION STUDY - 18 JULY 2024

On 18 July 2024, a joint workshop combining two sessions was conducted in BDD from 10:00AM till 4:00PM.

The first part revolved around the new national water sector strategy for 2024-2035 presented by M. Suzy Hoayek advisor of the Ministry of Energy and Water followed by an interactive discussion co-led by Alain Maroun the technical team leader for the Water Reform Programme. This session revolved around presenting the newly launched 2024-2035 National Water Sector Strategy (NWSS), aligned with Sustainable Development Goals and integrated water resources management

emphasize reform implementation, infrastructure development and system optimization to ensure water security and quality service.

The second part consisted on presenting the study of the socio economic barriers to subscription payment and servicing in the Lebanese water sector in partnership with LebRelief, IMPACT and Information International. This conducted study aims to explore opportunities for water policies that promote the inclusion of economically vulnerable populations in Lebanon.



The presentation of the study revolved around answering the following questions:

- What are the socioeconomic barriers
   for rights holders to subscribe
   to public water supply in Lebanon
   (physical, financial, legal...)
- What is the perception of rights holders on institutional capacity

to deliver water, (comparing Water Establishments and other institutions)?

- What is the right holders' willingness/ capacity to pay for services considering the new revised tariffs of the 5-year recovery plan?



## **NEWS FROM THE WASH SECTOR**

The WaSH sector has -initiated Advocacy Thematic Group to address significant challenges such as a declining budget and increasing needs across various population groups. This activation, group's highlighted in our recent sector alert paper, maps, and presentation at the Humanitarian Country Team (HCT) meeting, aims to integrate cross-cutting themes like disability, protection, conflict sensitivity, energy, and the environment, as adopted in the Lebanon Response Plan (LRP). With participants representing these themes and WaSH experts, the group is tasked with developing advocacy papers to support our sector in overcoming challenges. Additionally, the sector has produced an annex focusing on the difficulties women

face in accessing WaSH services in informal settlements, exacerbated by funding cuts over the past four years. The updated Waterborne Diseases (WBD) risk map for 2024 builds upon the 2022 cholera risk map, identifying high-risk areas and guiding emergency interventions such as vaccination campaigns, water quality monitoring, sanitation improvements, and community education.

#### STAKEHOLDER NETWORK ANALYSIS STUDY -IMPACT

Under the HawkaMaa-EU project, IMPACT initiative have conducted a study on the stakeholder network analysis over three river basins: Al Assi, Al Oustouan and Al Ghadir.

The research aimed to understand the relationships between key water actors and other stakeholders within three river basins in Lebanon: Al Ghadir (Mount Lebanon), Al Ostuan (North Lebanon), and Al Assi (Beqaa). The objective was

to better inform the management plans for the catchment areas. Additionally, it aimed to inform the implementation of relevant measures concerning roles, responsibilities and barriers associated with river basin management.

## ASSESSMENT OF THE CHARACTERISTICS OF THE MUNICIPAL SOLID WASTE COMPOST IN LEBANON

A research study was conducted by Lebanese University on municipal solid waste compost in Lebanon. The basic objective of this study was to determine the characteristics of the Lebanese municipal solid waste compost on a yearly basis and compare these characteristics amongst the years. Hence, each parameter was tested and compared to the BNQ international Canadian standards for proper classification of the compost and adequate identification of its usages.

The study was carried out in the experimental composting plant referred to as greensite situated in Karantina area pertaining to Beirut district. Representative samples were collected and tested for 11 years (2005-2016) and differences in the results came in but all showed conformity with the international standards.

## GOOD PRACTICES FOR DEVELOPING LEBANON'S NATIONAL ADAPTATION PLAN

The United Nations reports that almost all developing countries under the United Nations Framework Convention on Climate Change (UNFCCC) have a national adaptation plan (NAP) process underway as a subsequent crucial step to enhance their strategy and policymaking for climate change adaptation. The Government of Lebanon is in the early stages of its NAP process. In preparing to launch work

through a Green Climate Fund (GCF) Readiness Program grant with the UN Development Programme (UNDP), the Ministry of Environment requested support from the NAP Global Network to prepare a review of good practices and lessons from 12 peer countries' NAP processes.
